

# 2022 OVERSEAS STUDENTS SCHEDULE OF FEES



At St John's College we understand that choosing our College as the education provider for your child is a significant financial responsibility. Therefore, we are committed to providing an affordable education whilst ensuring our programs and facilities remain of a high quality. Fees are set each year in July and are provided to all current families at that time, as well as all families who are considering commencing in the following year.

## Registration Fee

A non-refundable fee of \$100 is to be paid for each enrolment application, per child. This fee is applicable for all year levels (Foundation to Year 12).

## Confirmation Fee

A non-refundable fee of \$500 is to be paid, in advance, for all new students entering the school once the student's enrolment has been accepted. This fee is deducted from the first term's fees.

## Year 7 Transition Enrolment Confirmation Fee

A fee of \$250 is payable upon acceptance of enrolment into Year 7 for students currently enrolled in Year 6 at the College. This fee is deducted from the first term Year 7 fees.

## 2. Inclusions from the Total Annual Fees

### Tuition

Core curriculum instruction and related learning resources/consumables. For example, photocopying, supply of printed materials, Junior School stationery and workbooks, literacy and numeracy manipulatives, sport equipment and art supplies.

### Consolidated Costs

Compulsory programs that form part of the curriculum. For example, incursions, excursions (including transport to/from events), inter-school and inter-House sports (Junior and Senior), College Athletics Carnival, guest speakers, Food Technology/Art consumables, Music instruments and equipment, Life Education Van, Year 9 Explore Week, Library services (online and material resources including TV4Education and fiction/non-fiction collection), subject competitions, student ID cards, school diary and the College Yearbook.

## ICT

The provision of ICT support and access to on-site ICT including networking infrastructure and hardware (computers/touch pads/iPads/printers/robotics etc.), Microsoft 365 and SEQTA licensing, internet access and connectivity, onsite anti-virus and firewall protection, and technical support. Also included are subscriptions, learning programs and support including, but not limited to, EdRolo (VCE), Mappen (Junior School), iPad APPS, literacy and numeracy programs F-10, and ACER PAT testing.

## 3. Exclusions from the Total Annual Fees

- The 2018 Laptop Program, uniform, textbooks, personal stationery, College production/concert tickets, canteen purchases and fundraising event costs are not included in the Annual Total Fees.
- Also excluded is the cost of one to one laptops; as part of the BYOD program (for students from Year 5 to VCE: Bring Your Own Device program).
- SJC Student ID card replacement: this is an important identification item for students. It is used by students for printing, photocopying, for book borrowing and for bus travel on our Private Bus Service. If lost, it must be reported immediately to the College so that the card may be cancelled. A new card will be reissued, and a replacement card fee will be charged to parents/guardians.

## 4. Optional Programs

Optional programs are not compulsory for all students and offered on a user pay basis. As such, they are not included in the Annual Total Fees. These programs include:

- Junior School swimming program.
- College camps at all year levels including local, interstate and international camps. Refer to table below.
- Out of School Hours Care Program: provided by VILLAGE OSHC.
- Private Instrumental Music: refer to the Instrumental Music Program flyer for further information.
- Private Bus Service: refer to the Bus Service flyer for further information.

## VET / TAFE and Virtual Schools

Senior School students participating in VET and Virtual Schools programs are charged 50% of the tuition fees charged by the outside provider and all materials charges. Program fees vary depending upon the course. If students withdraw from the course after the census date, parents are liable for 100% of the tuition fees charged.

If students are accessing Virtual School of Languages parents are liable for the total cost of program charges. Full fee-paying overseas students are also charged an administrative levy by VCAA which is payable by parents/guardians.

## 5. Annual Total Fee Concessions

### Sibling Concession

The sibling concession is calculated at a rate of 10% for the second child and 25% for the third and subsequent children (attending the College concurrently). The sibling concession will not apply where another concession is currently applicable to the student, or where the student is receiving other financial benefits from the College (for example a scholarship or sponsorship).

### Full Fee Payment in Advance Concession

A 5% concession will be applied for families who pay all Annual Total Fees for each child in their family by the 14<sup>th</sup> of February each year. This concession applies alongside all other concessions and is applied to the total fees invoiced (after sibling/staff concessions and before the Health Care Card concession).

### Healthcare Card Concession

For parents/guardians who hold a Health Care Card, a 5% concession will apply. The Health Care Card concession applies alongside sibling and clergy concessions. This concession is applied to the total fees invoiced after other concessions.

## 6. Terms of Payment

A Fee Payment Form must be completed by all parents/guardians by 30<sup>th</sup> November each year.

### Option 1: Termly Payments (standard terms of payment)

- Annual Total Fees are invoiced in four (4) instalments/quarterly.
- Term 1 due – February 14<sup>th</sup>
- Term 2 due – April 30<sup>th</sup>
- Term 3 due – July 31<sup>st</sup>
- Term 4 due – Oct 31<sup>st</sup>

### Option 2: Single Upfront Payment

- If paid in full by the February 14<sup>th</sup>, Annual Total Fees attract a 5% discount.

### Option 3: Monthly or Fortnightly Payments

- By agreement with the College, the Annual Total Fees are divided into equal instalments which are charged across ten months (between February/November). These arrangements need to be in place by 30<sup>th</sup> November of the prior year.

### **Administration Fee**

Any Credit Card, Ezi Debit, or Cheque payment that is declined by the bank, for any reason, will be charged the institution's administration fee.

### **Late Payment Fee**

A late fee of \$250 per account is charged when tuition fees are not paid by the due date.

### **Withdrawal of a Student**

If a student is withdrawn from the College, the Principal must be provided with a full term's notice in writing in advance. Failure to give the required notice will result in the requirement to pay a term's total fees (25% of the Total Annual Fee for each student). Where a student is withdrawn at the end of the year, notice is required by the first day of Term 4. The College reserves the right to withdraw an enrolment.

### **Building Fund Donation**

The Building Fund Donation of \$250 per annum, per family, is a voluntary tax-deductible gift to the School. The St John's College Building Fund is endorsed by the Australian Taxation Office, under subdivision 30-BA of the Income Tax Assessment Act 1997, as a deductible gift recipient for the operation of such a building fund.
