

Introduction



Child Safe Code of Conduct

The Child Safe Code of Conduct shows good standards of behaviour towards students for all adults at the College. It states the expectations for adults at working, volunteering or visiting our school.

It serves to protect students, reduce any opportunities for abuse or harm to occur, and promote child safety in the College environment. It provides guidance on how to best support students and how to avoid or better manage difficult situations.

- ~ We recognise the importance of friendships and encourage respectful relationships, strong friendships and support from peers.
- ~ We listen to children, taking their views seriously, and focus on addressing any of their concerns.
- ~ We communicate with parents and guardians about the wellbeing and safety of their children.
- ~ We listen to the views of staff, children and our community about our child safety practices, policies and procedures.
- ~ We listen to all concerns voiced about keeping children and young people safe from harm.

Professional Learning for Staff

Staff, volunteers and visitors have training before they begin at the College to understand their responsibility to child safety. They also have ongoing child safety training updates to make sure they keep learning about the government requirements for child safety and know what to do.

Risk Management

We all know that it is important to keep our College safe. All staff are responsible for identifying and managing risks to student safety. The College looks for problems or things that might be unsafe. If there are any problems, the school will fix them. Children and young people must let an adult know if they see a risk.



St John's College takes a zero-tolerance approach to child abuse and is fully committed to ensuring that its strategies, policies, procedures, and practices meet all Child Safety Standards as specified in Ministerial Order No. 1359 (2022).
