College Fees 2018

Tuition Fees

Accounts will be rendered prior to the commencement of each of term and will be due for payment within thirty days.

Where fees remain unpaid by the due date an administration fee will be charged to mitigate the cost of recovery.

A student may not be permitted to undertake co-curricular activities or excursions if fees or the levy are not paid.

Sibling Discount

First Child: Nil **Second Child:** 10% **Third Child:** 30% **Fourth and subsequent children:** 100%

The sibling discount is not available to families who receive other financial benefits from the College e.g. Scholarship or Bursary recipients.

Fee Discount

A 5% reduction of the tuition fee is available when the full year's payment is made at the commencement of the billing year. Pension card holders are also entitled to a 5% discount. The fee discount is not available to families who receive other financial benefits from the College e.g. Scholarship or Bursary recipients.

Payment Options

A direct debit arrangement through EziDEBIT is preferred. Fees may be paid weekly, fortnightly or by monthly instalments.

Other payment options include: electronic funds transfers, Credit Card (MasterCard/VISA), Cheque or Cash.

All contributions to the St John's College Building Fund are tax deductible. Please feel free to support the College from time to time.

TERMS & CONDITIONS

Registration Fee

A student's name will be registered as an applicant following the receipt of the enrolment form and the payment of the registration fee of \$100.00. This fee is applicable for all levels Prep – Year 12. The registration fee is to cover administrative costs and is non-refundable.

Enrolment Confirmation Fee

An enrolment confirmation fee is payable following the offer of a place. The enrolment confirmation fee is \$500.00 which is deducted from the college tuition fees.

College Levy

The College Levy is \$320.00 for both junior and senior students. The levy is payable in full at the beginning of the year. The levy covers most excursions and incursions.

Deferral of Enrolment

An enrolment can be deferred for entry in a later year following an acceptance of a place but does not guarantee that a place will be available at that time.

Withdrawal of a Student

If a student is withdrawn, the Principal must be notified in writing a full term's notice in advance. Failure to give the required notice will result in the requirement to pay a term's fees. Where a student is withdrawn at the end of the year, notice is required by the first day of Term 4. The College reserves the right to withdraw an enrolment.

Liability for Payment

Acceptance of an enrolment is acknowledgement that each signatory on the enrolment form is jointly and severally liable to the College for payment of all rendered accounts. This applies even if the accounts are usually paid by one parent or guardian. A parent or guardian of a child may not delay or refuse to pay an account on the basis that another parent or guardian of the child is responsible for payment of all or part of the account.

Acceptance of Business Regulations

Each person signing the enrolment form will be deemed to have accepted the above terms and conditions, as amended from time to time.
